Sheffield is the UK's 5th largest City with a population of over 1.5m people, and has an economy worth in excess of $\mathfrak{L}7$ billion per annum.

The subject property occupies a prime retailing location on the pedestrianised thoroughfare of Fargate. National multiple retailers in close proximity include Burger King, Boots, M&S, Caffe Nero, McDonalds, Superdrug, Tesco and GDK.

Situated close to the busy junction of High Street, Church Street and Fargate, opposite the Cathedral Tram Stop, the property benefits from high footfall from students, shoppers and office workers. Nearby Orchard Square is anchored by TK Maxx as well as a new and extensive food offerings increasing the number of shoppers within the vacinity.

Fargate has been designated £15.8 million from the Governments Future High Streets Fund. This investment will be delivered by March 2024 and look to introduce more co-working space, better public realm and exhibition space.
